

Indemnity and Release Form for Women's Health Fit Night Out (17 February 2018)

1. I am 18 (eighteen) years of age or older.

2. Your personal information is collected by the promoters for purposes of the Event and you agree that we may process your information also for health and safety reasons. Medical information may be used to provide medical assistance if required.
